Payment Terms and Conditions

Tuition fees are set as an annual fee and are payable as outlined in the Business Practices Summary. Please refer to this for full payment terms and conditions.

Method of Payment of School Fees

Payment of School fees may be made by the following means:

- cash (limits apply)
- credit card (VISA, Mastercard and Amex)
- EFTPOS
- electronic transfer into the School account
- direct debit

Please note that payments made by credit card will attract a 0.75% credit card surcharge.

Fahan School has a Board-endorsed policy for collection of overdue accounts, which includes charging interest on overdue accounts and referral to legal representatives for debt recovery action. Students will be denied the opportunity to participate in interstate and/or overseas trips, and their enrolment at Fahan placed under review, if their account is in arrears.

Related Charges 2026

In addition to the approved tuition fees, levies will apply to accounts as and where applicable.

Camps and Excursion Levy

Extra-curricular activities significantly extend teaching and learning outside the classroom such as camps, outdoor education experiences, excursions and special performances.

There may be additional fees charged. These include: Years 9 and 10 Outdoor Education experiences (extension beyond the standard camp), other interstate and international excursions.

These will be not included in the fees/levies and are billed separately.

Information and Communications Technology (ICT) Levy

The ICT levy supports secure, reliable learning environments, provides access to educational and commercial software, and maintains infrastructure that meets students' learning needs across the curriculum. The School supplies and manages devices for students from Kindergarten to Year 6. Fahan School is transitioning to a managed device program for Years 7 to 12, with Years 7 and 10 being the first adopters in 2026. These students will receive a School-owned Windows laptop that is managed by the School. This is the first stage of a three-year rollout of a School-managed, one-to-one laptop program in the Senior School, with all students participating by 2028.

ICT helpdesk support is available for all students.

Additional Charges

Extra-curricular Activities

Student elected activities, such as rowing, sailing and individual music tuition, attract extra charges as determined on an annual basis. Individual private music tuition is charged directly by the music tutor. Instrument hire is billed each term and is added to your account.

School Uniforms

Fahan School has a strict uniform policy. All students are required to be in correct uniform at all times.

Prepayment Discount

A 3% discount is applied if the full years' fees are paid by the due date on your annual statement. Full details are outlined in the Business Practices Summary.

Sibling Discount

Families with two or more children currently attending the School are eligible to receive a tuition fee discount as follows:

- 10% discount on second child's tuition fees
- 20% discount on third child's tuition fees
- 35% discount on fourth and more children's tuition fees.
